- Registered government bonds for special purposes
- Nominal value 250,000 Euros
- Maturity period 5 years

PROCEDURE OF BONDS PURCHASE AND PERMANENT RESIDENCE DRAWING-UP:

- **1.** Signing of contract
- Submission of documents
- 3. Receipt of the invoice due for payment
- **4.** Payment of the invoice by the investor (deposit is also possible)
- 5. Preparation of technical documentation for the place of proceedings
- **6.** Visit of the place of proceedings
- **7.** Verification of the investor
- **8.** Receipt of documents on the residence permit



TERMS OF PROCEEDINGS:



Outside Hungary - **45 days** In Hungary - **21 day**



PERMANENT RESIDENCE OBTAINING:

- Petition within 6 months after receipt of the residence permit
- Within 30 days from the date the petition
- Receipt of internal passport and registration card



CONDITIONS OF PROCEEDINGS:

- Filing of the application by the whole family or separately
- Receipt of the documents simultaneously
- Adult children are registered separately



RETURN OF INVESTMENTS:

- Filing of a formal request for investment return
- Investment return within 30 days

The provision of a bank guarantee for investment return from the part of Granit BankZrt is possible.



INVESTMENT CREDITING:

- Bank commission 70.000 Euros
- Administrative expenses 50.000 Euros
